Statement of Program Service AccomplishmentsTo serve as a powerful advocate and resource for Community Science Workshops, providing opportunities for youth to tinker, make, and explore their world through science in under-served communities across California The three main programs are technical assistance, grant-making, and staff training services to its member Community Science Workshop sites in six sites across California, altogether serving over 100,000 youth visits per year Technical assistance to member Community Science Workshop sites was one of our biggest programs in 2015 CSW Network provided financial management training, executive director coaching, evaluation system training, program management and fundraising training across the state CSW Network developed community awareness and marketing materials as well as represented the member sites in local, state, and national level meetings with stakeholders and funders This year the CSW Network provided emergency support to Fresno CSW to help negotiate a new staffing structure and fiscal sponsorship In Watsonville CSW, CSW Network staff managed the operations of the site during a leadership vacancy and director transition The Technical Assistance program is vital to enhancing the programs and operations of local workshops The CSW Network grant-making program provides funding to member Community Science Workshop sites CSW network funds programs that are free to low-income children and families The CSW network grant-making program funds traveling exhibits and supplies to educators who run free programs in the local workshops The network also purchased computers and equipment for CSW site educators, compiled new projects to the statewide project database, and executed a documentary project to capture alumni success stories over the past 20 years These efforts contribute to the CSW Network and the local sites capacity to raise more funds to increase open tinkering and making service hours to children and families who can not afford to go to museums or fee for service science centers The CSW Network designs and implements a year-round staff training program for educators employed at member Community Science Workshop sites Training topics include science concepts and curricula, workplace safety and sexual harassment, pedagogy and best practices, and special exhibit orientations In order to maximize the accessibility of these trainings, and therefore their positive impact on programs for youth, the CSW Network pays travel expenses, meals, and offers stipends for participating educators The CSW Network also makes it possible for educators to attend events and conferences relevant to the field of informal science education, where educators gain tools to enhance their local programs
