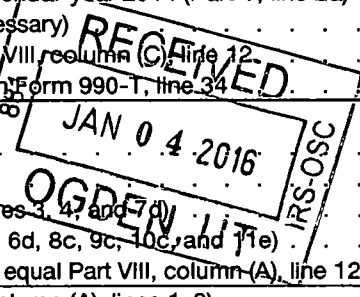

 Spektral Quartet NFP employs a classical string quartet (two violins, viola and cello) called the Spektral Quartet that serves the organization by promoting the education and expansion of music written for string quartet through performance and educational activities. Spektral Quartet NFP was formed in 2011 and since then has made in excess of 175 public appearances, commissioned more than 60 American composers, and has worked with public and private University students at Illinois State University, University of Wisconsin -Milwaukee, Northwestern University, University of Maryland, and the University of Chicago, where it currently serves as ensemble-in-residence for the Music Department. The large majority of the organization's activities occur within the Chicagoland Area, with some concert tours taking the quartet to Vermont, Pennsylvania, New York, Nevada, Indiana, Michigan and Wisconsin. Our organization served an estimated 6000-8,000 people during FY'15.
