OUR FIRST INITIAL RESILIENCY ACTION WAS RELEASED PRIOR TO HURRICANE SANDY IN 2012. AFTER SANDY, THE PROGRAM TOOK ON THE RESPONSIBILITY OF RESPONDING TO THE OVERWHELMING NEED FOR LOCAL SUPPORT AND CLEAR GUIDANCE AND STANDARDS TO ASSESS VULNERABILITIES AND STRENGTHEN LOCAL RESILIENCY.
