This amount excludes expenses associated with a number of additional community services provided by PHC. PHC attested to the Program Year 2014 of meaningful use. This attestation to CMS states PHC will meet and comply with the requirements for meaningful use. With this, PHC has enhanced patient care by implementing an electronic health record system as well as the many patient safety measure that comes with it.


