	Safe Harbor staff can be contacted via telephone 24 hours a day, 7 days a week, 365 days a year. The Organization shelters victims and children of domestic violence for a temporary period of time while they are looking for a new, safe place to live. The Organization also provides advocacy services for victims of domestic violence, sexual assault, bullying, and stalking. In FY2015, Safe Harbor assisted 1227 women, children and men that were victims of domestic violence. Safe Harbor also assisted 178 stalking victims, 44 sexual abuse victims, 27 adolescent sexual abuse victims, 54 child abuse victims, 55 domestic violence protection orders, and 24 stalking protection orders. The Organization sheltered 48 women and 34 children, providing 3,014 bed nights and 9,042 meals.

Kids Konnection served as a supervised visitation and exchange center for individuals referred by a court system, Department of Social Services, attorneys or others if there are difficulties exchanging children with another caretaker including when a court order restricts contact between parents or emotional safety is compromised In fiscal year 2015, there were 482 supervised child exchanges and 1023 hours of supervised visitation
