Children and Youth: The Cheyenne River Youth Project (CRYP) offers a wide variety
of interesting, innovative, educational and recreational youth programs
and services for the young people of the Cheyenne River Sioux Indian
Reservation ages 4-18. The CRYP campus is comprised of: The Main Youth
Center (ages 4-12); Cokata Wiconi Teen Center (ages 13-18); Family
Services; Winyan Toka Win Organic Garden and the Waniyetu Wowapi Graffiti
Art Park. The Main Youth Center is a drop-in after school youth services
facility that operates on an average of 5 days per week, from 4 pm -
8 pm during the school year and from 1 pm - 8 pm during the summer.
The Main was open for 173 days with 3,235 youth contacts. On average

CRYP created a Family Services Program in 2001 as a way to manage
the families CRYP serves on Cheyenne River and bring organization
to their distribution resources donated to the organization.
Enrollment in the program, guarantees the families access to bulk
distributions that include hygiene products, winter clothing and
coats, shoes, household goods (blankets, laundry detergent), clothing,
school supplies, emergency heat assistance, and other special programming
such as the annual Christmas toy drive. In addition, families may
request monthly individual services. During fiscal year 7/1/14 -
6/30/15, family services served approximately 381 families; 1,336 unduplicated
children.

Art Initiatives - In September, the Cheyenne River Youth Project was
proud to dedicate the Waniyetu Wowapi Graffiti Art Park, adjacent to the
Cokata Wiconi Teen Center. Waniyetu Wowapi, a 3.4 acre space, is
non-permit, free public space where members of CRYP's community can express
their own unique voices and life experiences in a positive, healthy
way. CRYP's new art park is located adjacent to the Cokata Wiconi Teen Center.
CRYP also created an art internship program which teaches youth the
art of creative lettering. In fiscal year 2015, CRYP had 9 youth
participates. Instruction is provided by artists that come from throughout
the region.
