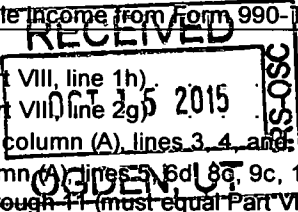

THE MISSION OF ADVANCING STUDENTS FORWARD (Part III, line 1)

The organization's primary purpose is to provide marginalized students with scholarships, academic support services and enrichment activities to promote their academic and professional success. The mission of Advancing Students Forward (ASF) is to provide disadvantaged students access to education and support for academic success so that they can provide a promising future for themselves and the community in which they live. ASF serves 75 needy students in grades 7 to the university level. Students must demonstrate economic need, provide evidence of good grades and live in the vicinity of the community center in the town of Tecolote in the city of Tijuana, Mexico. Students are required to participate in monthly meetings, maintain good grades and perform service projects.

SCHOLARSHIPS (Part III, line 4a)

75 needy students in various communities in Tijuana, Mexico are given economic assistance. This enables them to attend school beyond the 6th grade. Students are required to attend monthly meetings, participate in service projects and maintain good grades. Scholarships are given on a monthly basis to help with tuition and educational expenses provide they have fulfilled their monthly requirements and obligations to the program. Work Study opportunities are also available to the students at the community center. Students provide office support and tutor more than 70 children in the neighborhood. They serve as tutors for the many classes offered to the community, including homework support English and computer classes. Participants of ASF also prepare the curriculum and staff the month-long summer camp program for the elementary school children. ASF students are looked upon as role models in the community.

STUDENT SUPPORT (Part III, line 4b)

Students receive educational supplies, mentoring, opportunities for leadership, community building and parent/student workshops. During monthly student meetings students are supported in a variety of ways. This includes team building activities and educational presentations to provide academic support and guidance. University level students serve as team leaders. They direct the meetings and prepare educational presentations. Alumni of ASF continue to participate and mentor the current students. They also serve as ambassadors for ASF in the broader community. Parent/student workshops are offered 2-3 times a year to strengthen the child/parent bond. This helps to expand the parent's understanding of the academic challenges and requirements their children face and improves their communication, strengthening their relationships. Each academic year a specific curriculum is designed to meet the student's needs and to expand their horizons. The 2014-2015 school year was a continuation of EDUCARTE, the arts curriculum. During this time period students focused on the concept of murals. They studied the history and significance of murals in the Mexican culture. They created personal murals, team murals and were proud to work all together in the culminating activity when they created a community mural at the local elementary

school. Reporters from KPBS Television in San Diego documented this event. Video can be found on our website. Curriculum presented in past years include: Internet safety, internet etiquette, cyber-bullying, human trafficking, communication between adolescent and parent, public speaking, goal setting, self respect, sexuality and family values. Curriculum for 2015-2016 will focus on the academic areas of STEAM, Science, Technology, Engineering, Art and Mathematics. The University of San Diego is in partnership with ASF to support and guide this program.

ENRICHMENT (Part III 4c)

Enrichment activities include field trips to expose the students to the many cultural and educational opportunities in Baja CA, Mexico. Students have opportunities to attend conferences outside of Tijuana and students with visas participate in cross-cultural, binational events exchanges with students on the U.S.A. side of the border including the International Friendship Games in Chula Vista, CA and World Link Conference at the University of San Diego. In 2015 the student field trip was led by Turista Libre. Students visited numerous murals throughout Tijuana. Local muralist Enrique Chiu served as docent.

Each year approximately 10 new students are accepted into the program of ASF. In 2015 6 students graduated from middle school, 5 graduated from high school and one will graduate in December from the university. The university students work full time in their field of study. Currently for the 2015-2016 school year, ASF serves 25 students in middle school, 22 in high school, 18 in the university and one in technical courses. The majority of students in Advancing Students Forward participate for 6-10 years.
