Commonly requested workshops and seminars included a variety of historic preservation and organizational development topics, such as the basics of real estate finance, how to facilitate effective meetings, recruit volunteers, develop a fundraising plan and build an effective membership program (continued on schedule O)

In FY2015, the NMSC focused on delivering excellent benefits and high value services to the NMSC network through its membership program. The NMSC also improved the design and substance of its major communications offering for members, the e-newsletter Main Street Weekly (continued on schedule O)

From 1980-2013, cumulatively, commercial districts taking part in the NMSC program have spurred the historic rehabilitation of more than 246,000 buildings, and generated \$59.6 billion in new investment, with a net gain of more than 502,728 new jobs, and over 115,000 new businesses. Every dollar a community used to support its local NMSC program leverages an average of \$18 in new investment, making the Main Street Four-Point Approach one of the most successful economic development strategies in America. These community benefits would not be possible without the training, education, and leadership of the NMSC.
