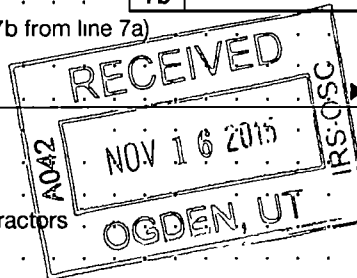

HOUSEHOLDS ARE WELCOME TO ACCESS THE FOOD PANTRY ONE TIME PER MONTH. AND WILL RECEIVE A BOX OF PRE-PACKED FOOD. WE SERVE ABOUT 100 FAMILIES EACH WEEK THROUGH THE FOOD PANTRY. MUCH OF THE FOOD IS DONATED TO THE PANTRY FROM LOCAL CHURCHES. ALL SERVICES ARE OFFERED WITHOUT REGARD TO RACE, SEX, OR RELIGIOUS AFFILIATION.
