During FYE 6/30/15, the Foundation provided \$58,200 in grants to the City of Burlington, VT to fund several projects: \$4000 to mark lines for Pickleball; \$40,000 for new Skate Park; \$1200 for new gym floor at Miller Center; \$10,000 for Big Belly Solar and \$3000 to set up a scholarship fund. These improvements benefitted residents of both the North and South ends of Burlington. The Skate Park gives kids and teens a positive place to gather and focus their energy while working on coordination, physical strength and agility, pursuits which oftentimes provide inspiration for creating art and music.
