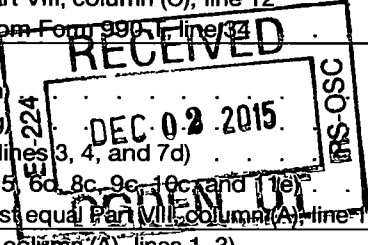

For Baan Saan Rak (BSR) Mae Lao village, Chiang Rai, Thailand
BSR is a small orphanage caring for 21 impoverished and abandoned children. On May 5, 2014 the facilities at BSR were severely damaged by the 6.0 earthquake that struck Northern Thailand (In fact, the epicenter was in Mae Lao village). Approximately 85% of the above funding was to rebuild two buildings damaged beyond repair. The remaining 15% was for minor maintenance to the remaining buildings and for general operating expenses

Rotary Club of Maechan, Thailand.
This grant of \$8,500 was provided to that the Rotary Club of Maechan could continue offering "starter scholarships" to qualified hill-tribe high school students thereby enabling them to begin their university studies. This provided them with opportunities that would have otherwise been way beyond the realm of possibility for them
