 Dedicated to rescuing, protecting and providing sanctuary for elephants worldwide. Our founding directors and elephant care specialist consult internationally for the well-being of captive and have relocated to Brazil to spearhead the development of our pilot project, Elephant Sanctuary Brazil. Presently 5 countries in South America have banned performing elephants, two more are expected to do the same in near future but all lack a healthy alternative. Elephant Sanctuary Brazil is the solution for a healing, dignified and respectful future

 We have dedicated our founding directors to oversee the development of the first expansive sanctuary for captive elephants in South America, Elephant Sanctuary Brazil. During 2014, they conducted an extensive property search which lead to securing 2800 acres to be the future sight of the sanctuary. They established key relationships with authorities and individuals, helped to establish the non-profit organization in Brazil (Associação Santuário de Elefantes Brasil,) and established a reputation as international authorities for the health and well being of captive elephants. We are grateful for key pledges that arrived this year to be distributed over 4 years (dedicated to Brazil sanctuary development) as well as growing support within Brazil from citizens, business owners and government officials

 In conjunction with Chilean non-profit organization, Ecopolis Disciplinas Integradas, we oversee the care of Ramba the elephant. Confiscated more than 3 years ago, Ramba remains in temporary housing awaiting transfer to sanctuary in Brazil as soon as possible. Presently we consult with daily oversight for Ramba caregivers and provide grants to support the caregiver salaries and dietary and medical supplements.

 We actively assist international organizations such as the Humane Society of the United States, working on the protection of captive elephants, through consultation and expert testimony.
