PART II	From the time of incorporation until September 9, 2014, the Mesivta High School was associated with Young Israel of the Main Line, 273 Montgomery Avenue, PO Box 117, Bala Cynwyd, PA 19004 (EIN # is 23-2886892).
PART II	A Fiscal Sponsorship Agreement had been created, effective June 26, 2013, by and between Young Israel of Main Line (the "Sponsor"), a Pennsylvania nonprofit corporation described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, The Mesivta High School of Greater Philadelphia (the "Project"), and Rabbi Avraham Steinberg (the "Project Director"). The Board of Directors of Sponsor had reviewed the purpose, proposed activities and budget of the Project and determined that the Project would be in furtherance of the charitable purposes of the Sponsor. The Sponsor acted as a fiscal sponsor of the Project and, as such, the Board of the Sponsor authorized the establishment of a restricted fund to receive donations and to make disbursements in furtherance of the Project's charitable purposes and activities. The Project Director agreed to oversee the Project on behalf of the Sponsor.
