Papahana Hoolauna is a program that focuses on teaching and perpetuating traditional Hawaiian navigation culture by providing classroom and hands-on learning opportunities aboard the canoe "Kanehunamoku " Papahana Hoolauna provides services to a wide variety of populations of all ages, serving Hawaiian focused charter and private schools, as well as providing educational opportunities to public school students and the general public throughout Hawaii Participants in this program learn the history of Hawaiian voyaging, as well as methods used in wayfinding and sailing

Halau Holomoana is a Hawaiian voyaging cultures based college and career success program that prepares Native Hawaiian youth grades 11-12 for future careers in the contemporary maritime industry The program provides participants with a strong sense of cultural pride and teaches students maritime skills by contextualizing their education from their own cultural worldview Students learn maritime as well as traditional navigation skills over several weekends, culminating in a 10-day open ocean voyage where students are able to put their traditional and contemporary skills to the test Students receive college and career planning supports, as well as post high school supports for attaining the highest degree of training and educational achievement for the maritime field in which they choose Supports include mentorship, counseling, scholarships, and ongoing opportunities to maintain their connection to the greater ohana wa`a

Connecting Oceanic Pathways is a program that seeks to overcome challenging strains in the relationships between Native Hawaiian and Micronesian youth on the island O`ahu through the medium of cultural sharing Native Hawaiian and Micronesian youth both face challenges stemming from the historical exploitation of their indigenous lands, some of which has caused a major increase in Micronesian immigration into Hawaii Connecting Oceanic Pathways brings these two groups together to show them that Native Hawaii and and Micronesians have similarities than differences During this project, the youth worked together under Micronesian master canoe carver Plasito Esilquipi to learn how to make a micronesian canoe Later the youth celebrated the completion of the canoe among the two communities coming together Future activities under this program will bring these youth back to learn to sail the canoe
