Additionally, in 2009, Town Hall Meetings were conducted in each of the cities in Buffalo County. Instead of an insulated and internal process of prioritization within the hospital, the hospital and its partners conduct the prioritization of health needs in our community collaboratively. Through the coalition's "Planning and Measurement Committee" we conducted a detailed review of the results of the various surveys, hosted town hall meetings and other focus groups and opportunities to gain community input. Public Health Data Reviewed. The following assessments were conducted and reviewed: 2010 Buffalo County Youth Risk and Protective Factor Survey, 2010 Youth Behavioral Risk Factor Survey, Part 1 Part 2, 2009 Youth Behavioral Risk Factor Survey, 2007 Youth Behavioral Risk Factor Survey, 2010 Adult Behavioral Risk Factor Survey, Part 1, 2, 3, 2009 Minority Behavioral Risk Factor Survey, Part 1, 2, 3, 4 & 5, 2009 Town Hall Meetings Report, 2007 Adult Behavioral Risk Factor Survey, Part 1, 2, 3, 4 & 5. Assessment Process. Assessments are an essential part of the model created by Buffalo County Community Partners. BCCP funding requires that programs be evidence-based, meaning they are dependent on measurable results and outcomes to determine their effectiveness and are proven effective in communities similar to Buffalo County. The assessment process is a fluid process that is coordinated by the Board's Planning and Measurement Committee. The committee has outlined steps below that are followed to ensure a consistent and living assessment process.</p> <p>Step 1 - In 2008-2010, the Community Partners conducted a countywide assessment to determine which priority health goals should be attained by 2020. Assessment tools used for the countywide assessment include, Behavioral Risk Factor Surveys for adults, minority and youth in Buffalo County (these surveys are linked in the section above). To secure the qualitative data, the Partners conducted a focus group process called Mini-Town Hall Meetings in each Buffalo County community, networking with 300 residents including youth and minorities. The most recent town hall meeting report is linked in the section above. During this same process, the Planning and Measurement committee overlaid data to determine if Buffalo County 2010 Goals were attained. See Appendix 4 for a report on the 2010 goals.</p> <p>Community Health Needs Assessment Executive Summary 4. Step 2 - The matrix found on page eight of the Town Hall Meeting report lists the health issues prioritized by Buffalo County communities. The qualitative data was prioritized by members of each community to begin developing the Buffalo County 2020 Vision.</p> <p>Step 3 - Buffalo County Community Partners Planning and Measurement Committee aligned the qualitative priorities with quantitative data to define a list of countywide priorities. The Committee utilized Healthy People 2020 to set measurable targets for each priority. The list of priorities was developed and presented to the board. The board defined goals by aligning to the 'determinants of health' and resources on Healthy People 2020 website.</p> <p>Step 4 - The Board voted on the top ten issues to be addressed in Buffalo County. Planning and Measurement Committee processed the issues into a dashboard of well-being indicators with measurable outcomes. At this time, the board determined to address the well-being indicators in five strategic directions to be adopted by the community for attainment by 2020.</p> <p>Step 5 - The strategic directions were released to the community through the 2010 Annual report to the community. This report is updated annually and for 2012 can be accessed here. 2012 Annual Report. A new Buffalo County Healthy Community Advisory Board was launched in July 2012 to adopt the five strategic directions and model programs in the community. The Advisory Board will meet annually to discuss business approach to moving the five strategic directions for Buffalo County.</p> <p>Step 6 - The Collaboration Council will be launched for members of the community to meet quarterly to discuss action plan processes and objectives moving the 5 strategic directions toward 2020 to meet well-being indicator targets. Ongoing processes that weave through all five steps listed above include Planning and Measurement's monthly meeting to mark community wide surveying and focus group processes, reports to the community and marking progress. In addition, Good Samaritan Hospital registration clerks are trained to provide consultation to those who have no insurance or potentially inadequate insurance concerning their financial options including application for Medicaid and for financial assistance under Good Samaritan Hospital's financial assistance policy. Upon registration (and once all EMTALA requirements are met), patients who are identified as uninsured (and not covered by Medicare or Medicaid) are provided with a packet of information that addresses the financial assistance policy and procedures including an application for assistance. Good Samaritan Hospital registration clerks read the organization's medical assistance policy to those who appear to be incapable of reading, and provide translators for non-English-speaking individuals. Good Samaritan Hospital's staff will also assist the patient/guarantor with applying for other available coverage (such as Medicaid), if necessary. Counselors assist Medicare eligible patients in enrollment by providing referrals to the appropriate government agencies.

The assessment included a review of public health data over several years, Youth Risk and Protection Factor Survey in 2010, the Adult Behavioral Risk Factor Survey in 2010, and the Minority Behavioral Risk Factor Survey in 2009. Additionally, in 2009, Town Hall Meetings were conducted in each of the cities in Buffalo County. Instead of an insulated and internal process of prioritization within the hospital, the hospital and its partners conduct the prioritization of health needs in our community collaboratively. Through the coalitions "Planning and Measurement Committee" we conducted a detailed review of the results of the various surveys, town hall meetings and other focus groups mentioned above. Twelve key factors having the greatest impact on the overall wellness of the area emerged in the Community Health Status review: 1 Obesity 2 Mental Health 3 Access To Care 4 Community / Housing Development 5 Alcohol Use 6 Youth Illegal Drug Use 7 Tobacco Use 8 Teen Sexual Activity 9 Alzheimer's Disease / Dementia 10 Domestic Violence / Child Abuse 11 Adult Seat Belt Use 12 Youth Financial Responsibility. These needs were further prioritized into 5 main health focus areas for the community: 1 Healthy Eating & Active Living 2 Eliminate Health Disparities 3 High-Impact Prevention Services 4 Healthy Homes and Sustainable Communities 5 Injury-Free Living. Good Samaritan/Priorities: Four of the areas of need above were prioritized and selected by Good Samaritan Hospital/ Richard Young Behavioral Health as aligned health needs and are now part of the Implementation Plan shared by the hospital. In addition, Good Samaritan prioritized violence as a key community need. These priorities and the related strategies are below: Healthy Eating & Active Living - a Launched program with Buffalo County elementary students to address childhood obesity and inactivity.
