In comparing HUD guidelines to the Federal Poverty Guidelines ("FPG"), we find that on average HUD guidelines compute to approximately 200% to 250% (and sometimes 300%) of FPG. Alegant Health-Bergan Mercy Health System bases its financial assistance eligibility on HUD's 130% of Very Low Income Guidelines based on geography, and affords the uninsured and underinsured the ability to obtain financial assistance write-offs, based on a sliding scale, ranging from 25%-100% of charges. An individual's income under the HUD guidelines is a significant factor in determining eligibility for financial assistance. However, in determining whether to extend discounted or free care to a patient, the patient's assets may also be taken into consideration. For example, a patient suffering a catastrophic illness may have a reasonable level of income, but a low level of liquid assets such that the payment of medical bills would be seriously detrimental to the patient's basic financial (and ultimately physical) well-being and survival. Such a patient may be extended discounted or free care based upon the facts and circumstances.

Leadership from Alegent Creighton Health participate in multiple internal and external venues to garner community input, prioritize community health needs and develop community health improvement plans. Mercy Hospital leadership (Marie Knedler, Vice President and Chief Operating Officer, Chris Evans, Campus Operations Leader, and others) have been part of a Pottawattamie County leadership group that has been meeting since 2011 to analyze the CHNA and pursue funding opportunities to support a community coalition to address the poor health outcomes of Pottawattamie County. On May 1 and 2, 2012, Mercy Hospital hosted and funded a facilitated community based strategic planning session (known as a Decision Accelerators) with 56 participants representing business, government, elected officials, healthcare, schools and social services to discuss the health of Pottawattamie County. During the two day Decision Accelerator, the CHNA contributed to identification of a community health priority and group consensus of the following vision: Our Vision is to Lead the State in Healthy Eating and Active Lifestyles. We will work together as a coalition dedicated to improving nutrition and physical activity where people work, play and live by helping to make the healthy choice the easy choice. The CHNA covers four counties served by the Alegent Creighton Health Omaha and Council Bluffs hospitals. The CHNA reports data at the county level and for Douglas County, by four quadrants within the county. Particular to the county in which Mercy Hospital resides, Alegent Creighton Health partners with local health departments, Live Well Council Bluffs and competing health systems to retain Professional Research Consultants to conduct a CHNA for the Omaha/Council Bluffs metropolitan service area. The CHNA covers four counties served by the Alegent Creighton Health Omaha and Council Bluffs hospitals. The CHNA reports data at the county level and for Douglas County, by four quadrants within the county. Alegent Creighton Health leaders serve on the CHNA Steering Committee and participate in key informant interviews conducted at hospital locations; they also participate in the implementation plans. The CHNA is shared in multiple venues with the public, including at the Live Well Omaha Summit. Alegent Creighton Health is one of the founders of Live Well Omaha. In addition, Alegent Creighton Health has joined with local health systems and health departments to fund the web based Community Health Dashboard (http://www.douglascohealth.org/). The CHNA process for the hospital included both quantitative and qualitative sources. Quantitative data input includes primary research (the PRC Community Healthy Survey) and secondary research (vital statistics and other existing health-related data). These quantitative components allow for trending and comparison to benchmark data against the state and national levels. Qualitative data input includes primary research gathered through a series of key informant interviews. The survey instrument used for the CHNA is based largely on the Centers for Disease Control and Prevention Behavioral Risk Factor Surveillance System, with the final survey questions developed by the Sponsors and PRC, similar to previous CHNAs used in the region allowing for data trending. The Hay Group reviews both cash and total compensation for overall reasonableness, for adherence to CHI's compensation philosophy, and for comparability to the not-for-profit healthcare market. This independent review is delivered by Hay Group to the HR committee of the CHI Board of Stewardship Trustees annually at their September meeting and minutes are shared with the full board at the December meeting. The last review was September 14, 2015. In addition, Hay Group completed a comprehensive review of all positions at the level of vice president and above in the fall of 2014 to determine and validate appropriate compensation levels. These levels have been reviewed annually since and revised based on market data, where applicable.
