Donations to the Agricultural Society included \$65 for Open Class special awards, \$850 for campers parked during the fair on the grounds, and \$315 in gifts for use of bleachers and the horse arena. A fund-raising campaign for a new open-sided metal beef barn continued in 2014. The following amounts were received in this fiscal year: \$1000 each from the Bertrand Vet Clinic, Jim and Julie Nelson, and Larry and Dorla Lindstrom; \$2600 from Morten Electric; and \$42,275 from the Phelps County Community Foundation. The Phelps County Community Foundation also held a one-day give2Grow activity that brought \$6,558 in donations for erection of a new flag pole at the Ag Center in Holdrege.
