"Omaha Performing Arts Presents" is the major presenting series of OPA and includes performances of the highest quality by artists and ensembles at venues including the Orpheum Theater and the Holland Performing Arts Center Performances span a wide variety of genres in seven series of performances Broadway, Showcase, Dance, Jazz, Family, National Geographic Live, and 1200 Club at the Holland In addition, OPA presents free community performances, including Jazz on the Green and Music and Movies The "Omaha Performing Arts Presents" series continue to attract new performers and patrons to the Omaha community each season The 2014/2015 season included performances by David Sedaris, Cassandra Wilson, and Pilobolus Dance Theatre, as well as the presentation of the Radio City Christmas Spectacular

Omaha Performing Arts is dedicated to reaching all members of the community through its education and community engagement programs These programs help to eradicate barriers that often prevent certain groups of citizens from having regular access to the performing arts Through the past ten seasons, OPA has increased the number of active participants in programs such as Arts Access and the Student Matinee Series, which provide free or deeply discounted tickets to students, educators, and community groups OPA has also established a network of community organizations that it partners with in order to bring both new and established audiences to the arts Collaborations have taken place with the Omaha Symphony, Opera Omaha, Omaha Public Schools, Girls Rock, Salem Baptist Church, University of Nebraska Omaha - Jazz Studies program, Omaha Community Playhouse, Ballet Nebraska, Hear Nebraska, Film Streams, and others Beginning in 2014, Omaha Performing Arts implemented the Nebraska High School Theatre Awards, a program which celebrates the artistic achievements of local high schools, students and teachers involved in musical theatre, supports high schools by providing high-quality learning experiences for students, and advocates for the importance of high school theatre education During the 2014/2015 season, approximately 24,000 students, educators, and members of the community benefited from these programs
