Conflict of Interest Policy Monitoring & Enforcement	Form 990, Part VI, Line 12c Conflict of Interest Forms are provided three times a year, once at each board meeting and one in the summer. A summary is compiled and sent via e-mail to the board chair for review at the next board meeting. The Compensation and Conflicts Committee identifies on an annual basis a list of persons having a conflict. In addition, all interested persons should report any conflict that arises in the interim. If a conflict arises, the person having the conflict shall leave the board or committee meeting while the matter is discussed and be prohibited from voting on the matter. If a board member were found to have a conflict of interest, the issue would be raised to the Board Chairman by the President. Should the conflict of interest require an Executive Committee or Board vote to resolve, those concerned shall not be present at the time of the vote.
