Pregnancy, parenting and adoption services give young mothers the support and incentives they need to become self-sufficient and nurturing parents, or to create an adoption plan. The adoption process is the start of a life-long relationship between birth parents adoptive parents and a child. There were 54 inquiries regarding infant adoption, 4 families prepared for adoption, and 1 infant placed with adoptive parents. Additionally, pregnancy counseling was provided to 45 people, and services were provided to 18 teen moms.

Family strengthening programs provide relationship and marriage education classes to help individuals and couples learn relationship-building skills that benefit both themselves and others. Also, counseling for addiction or relapse prevention helps individuals and families develop habits and behaviors for happier success in all areas of life. 89 couples completed Healthy Relationship Classes, and 64 individuals received addiction counseling services.

Family sustaining programs strive to connect individuals and families with resources such as housing, utilities, food, and other essential supplies to meet their basic needs. 24 families were provided housing services, additionally, 404 families were assisted with baby food, diapers, cleaning supplies, toiletries, other essential supplies, and referrals to other services to meet their needs.
