SCWIB provides workforce development opportunities and resources in an eight county region of south central Pennsylvania. The agency oversees six Pa Careerlink Offices for job seekers and employers as defined in the Federal Workforce Investment Act. The SCWIB focuses on contracting with programs that enable employees, dislocated workers, EARN participants, and youth to attain the job skill competence required by employers.

The organization expended Federal Workforce Investment Act formula Title 1 and discretionary grant funds to enroll 1,572 adult, youth, and dislocated workers in job training and development services. Rapid Response, core and intensive job search and development activities were provided for major layoffs in the eight county south central region of Pennsylvania. Over 35,500 participants were eligible for those services which included workshops, on-the-job training and skill specific training. Initial core service and eligibility determination and assessment occur at any of the six One Stop Centers(Pa CareerLinks) within the eight county south central Pa region in accordance with the WIA Act. Program services fund Title I subcontractors providing case management, individual skills training, tuition, and on-the-job training reimbursement. Eligible participants served included: 405 In-School youth and 245 Out-of -School youth. Rapid response individuals impacted by major layoffs, adult and dislocated workers: 502 adult and dislocated workers received tuition based training or on-the-job training and rapid response events were held for employee layoffs under the WARN notifications. Youth placement rate is 65%, adult job retention rate is 88%, and the dislocated worker job retention rate is 98%, all meeting State performance goals.

4b (Code:) (Expenses \$ 7,685,432 including grants of \$ 7,685,432) (Revenue \$ 7,685,732)
Federal and State grants awarded to subcontractors to enroll 890 welfare TANF adult participants and joint jobs initiative programs over the twelve month fiscal period. 44.72% or 398 participants claimed job placements of 20 or more hours per week. The measurable job retention rate was 30.3% or 121 of those placed who retained jobs for six months thru July 1, 2015 and thereafter. Work activities programs such as work experience for enrollees were funded. The Department of Public Welfare contracted with the SCWIB to contract with subcontractors to provide special services to a population of recipients throughout Pa. The services were provided in the following sectors: Dress for Success, Community College Assistance Programs, Non-Custodial Parent Assistance Program, and Overcoming Employment Barriers.

\$78,150 in grants were received in Industry Partnership Incumbent Worker program for the manufacturing sector. Industry Partnerships also exist for logistics and transportation, health and life sciences, IT, Building and Construction throughout the south central region. Over 270 participants received employment and development advanced training. The manufacturing grant was a pass-thru award from the State Employment and Training funds from the Pa Department of Labor and Industry to be utilized on program services provided by educational and other non-profit organizations. The number of companies participating in the upgrade of job skills by industry are as follows: Advanced Manufacturing, 121; Education, 47; HealthCare, 52; IT, 177; and Transportation, 77.
