THE MARYLAND FOOD BANK IS A NONPROFIT HUNGER-RELIEF ORGANIZATION, LEADING THE MOVEMENT TO END HUNGER THROUGHOUT MARYLAND. FOR MORE THAN 35 YEARS, THE MARYLAND FOOD BANK HAS PARTNERED WITH COMMUNITIES ACROSS THE STATE TO DISTRIBUTE FOOD TO INDIVIDUALS AND FAMILIES IN NEED. CONTINUED FROM PAGE 2, PART III, LINE 1 THROUGH CAREFULLY CRAFTED PROGRAMS, THE FOOD BANK AIMS TO MEET THE IMMEDIATE NEEDS OF MARYLANDERS WHILE SIMULTANEOUSLY WORKING TO FIND LONG TERM WAYS TO REDUCE HUNGER STATEWIDE. CURRENTLY DISTRIBUTING MORE THAN 100,000 MEALS A DAY, NEARLY 37 MILLION MEALS ANNUALLY, THE MARYLAND FOOD BANK WILL CONTINUE TO EXPAND ITS EFFORTS UNTIL HUNGER ENDS.

MORE THAN THIRTY YEARS EVERY DAY, MARYLAND FOOD BANK TRUCKS ARE ON THE ROAD, DISTRIBUTING FOOD TO A NETWORK OF APPROXIMATELY 1,250 DISTRIBUTION PARTNERS , PANTRIES, SHELTERS, SCHOOLS AND OTHER COMMUNITY-BASED ORGANIZATIONS ACROSS ITS 22-COUNTY SERVICE AREA BEYOND PROVIDING MILLIONS OF POUNDS OF FOOD EACH YEAR, THE MARYLAND FOOD BANK NURTURES THESE LOCAL ORGANIZATIONS WITH TRAININGS, GRANTS, AND MUCH-NEEDED EQUIPMENT LIKE REFRIGERATORS, CHEST FREEZERS AND SHELIVING THE MARYLAND FOOD BANK IS CONSTANTLY EVALUATING ITS NETWORK, RECRUITING MORE PARTNERS IN UNDERSERVED COMMUNITIES, AND FACILITATING COLLABORATION AND RESOURCE SHARING BETWEEN EXISTING PARTNERS TO EXPAND SERVICES AND BETTER MEET THE NEED THE MARYLAND FOOD BANK ALSO OVERSEES SEVERAL INNOVATIVE PROGRAMS THAT FURTHER BRIDGE SERVICE GAPS SUPPLYING HEALTHY, NUTRITIOUS FOODS, ADDRESSING ROOT CAUSES OF HUNGER, AND REACHING POPULATIONS AND GEOGRAPHIC AREAS THAT REMAIN UNDERSERVED AMONG THESE PROGRAMS ARE THE FARM TO FOOD BANK PROGRAM, WHICH ADDRESSES CHALLENGES IN SUPPLYING NUTRITIOUS, FRESH FOOD BY SECURING DONATIONS DIRECT FROM LOCAL FARMS FARMS CAN DONATE DIRECTLY, ALLOW THE FOOD BANK TO CONDUCT SECOND AND THIRD GLEANINGS IN FIELDS, OR CONTRACT TO GROW THE TYPES AND QUANTITIES OF FOOD THAT CLIENTS NEED MOST IN FY 15, THE MARYLAND FOOD BANK PARTNERED WITH MORE THAN 70 GROWERS AND DISTRIBUTED A TOTAL OF 9 PANTRY PROGRAM ESTABLISHES FOOD PANTRIES WITHIN SCHOOLS THAT HAVE HIGH LEVELS OF PARTICIPATION IN THE FREE AND REDUCED PRICE MEAL PROGRAM FAMILIES IN NEED HAVE CONSISTENT ACCESS TO FOOD THROUGH AN INSTITUTION THAT IS PART OF THEIR EVERYDAY LIVES SCHOOL PANTRIES ALSO WORK TO ENGAGE PARENTS IN VOLUNTEERISM, HELPING TO STRENGTHEN THE COMMUNITY AND DE-STIGMATIZE SEEKING FOOD ASSISTANCE IN FY 15, THE MARYLAND FOOD BANK'S 259 SCHOOL PANTRIES DISTRIBUTED NEARLY 5 MILLION MEALS TO FAMILIES IN NEED THE SUPPER CLUB PROGRAM SERVES HEALTHY MEALS TO KIDS ENROLLED IN AFTERSCHOOL PROGRAMS INSTEAD OF GOING HOME TO EMPTY CUPBOARDS, KIDS HAVE A HEALTHY DINNER, FOLLOWED BY SPORTS, ARTS AND CRAFTS, HELP WITH HOMEWORK AND MORE SUPPER CLUBS ARE HELD AT SCHOOLS, BOYS & GIRLS CLUBS, YMCAS, POLICE ATHLETIC LEAGUE CENTERS, AND OTHER COMMUNITY ORGANIZATIONS LAST YEAR, THE SUPPER CLUB PROGRAM PROVIDED NEARLY 262,000 MEALS AT 57 SITES IN FY 15, THE MARYLAND FOOD BANK BEGAN PREPARING THE MAJORITY OF SUPPER CLUB MEALS IN THE BAUER COMMUNITY KITCHEN USING FRESH, LOCALLY-SOURCED PRODUCE THE SUMMER CLUB PROGRAM PROVIDES HEALTHY BREAKFASTS AND LUNCHESES TO CHILDREN WHO RELY ON THE FREE AND REDUCED PRICE MEAL PROGRAM DURING THE SCHOOL YEAR, BUT HAVE NOWHERE TO TURN DURING THE SUMMER LIKE SUPPER CLUBS, SUMMER CLUBS ARE HELD AT SCHOOLS, BOYS & GIRLS CLUBS, YMCAS, POLICE ATHLETIC LEAGUE CENTERS, AND OTHER MEALS IN THE BAUER COMMUNITY KITCHEN, USING FRESH, LOCALLY-SOURCED PRODUCE SNAP OUTREACH AIDS LOW-INCOME INDIVIDUALS WHO LACK TRANSPORTATION AND TECHNOLOGY IN APPLYING FOR SUPPLEMENTAL NUTRITION
