As a proud member of MedStar Health, MedStar Washington Hospital Center's (MWHC) mission is to deliver exceptional patient first health care to the region with the highest quality and latest medical advances through excellence in patient care, education and research. MWHC is an acute care teaching and research hospital located in northwest Washington, D.C. It is the largest private hospital in the nation's capital and among the 50 largest hospitals in the nation. In fiscal year 2015, MWHC had 38,156 inpatient admissions, and 547,166 outpatient visits including 87,009 emergency visits.

MedStar Washington Hospital Center's is the city's largest and busiest hospital, providing acute care services to the communities of northeast Washington, D.C. and the surrounding areas. In addition to the program service expenses listed above, MWHC incurred \$272.0M of management and general expenses in providing services to its communities. It offers primary, secondary and tertiary health services to adult and neonatal patients. It is a major referral center for the most complex tertiary services and operates the region's only adult burn center. MedStar Heart & Vascular Institute, headquartered at MWHC, is a national leader in the research, diagnosis and treatment of cardiovascular disease. In 2013, MedStar Heart & Vascular Institute formed a first-of-its-kind clinical and research alliance with the Sydell and Arnold Miller Family Heart & Vascular Institute at Cleveland Clinic. MWHC's organ transplantation capabilities include heart, pancreas and kidney transplants. Its cancer center offers cancer treatment, therapies and access to cutting-edge clinical trials. The hospital operates the largest, private, hospital-based ground and air ambulance shock-trauma service in the region. It also offers comprehensive ambulatory care through a wide range of medical and surgical specialty outpatient clinic programs. MWHC operates the region's only Joint Commission-certified Comprehensive Stroke Center and Cardiac Ventricular Assist Device Program. In fiscal year 2015, U.S. News & World Report recognized MWHC's cardiology and heart surgery program as one of the nation's best. MWHC is the only hospital in the Washington metropolitan area to earn a national ranking for heart care.

MedStar Washington Hospital Center provided \$52.0M in health professions education in fiscal year 2015. This category includes training in graduate medical education, and education for physicians, medical students, nurses, and other health professions.

MedStar Washington Hospital Center provided \$26.4M in subsidized (mission driven) health services in fiscal year 2015. These critical services, which are driven by community needs, operate at a loss. They address priorities primarily through disease prevention and improvement of health status. Services provided include outpatient primary care, emergency department coverage, cancer, diabetes and stroke treatment, and cardiology.
