MedStar Georgetown is an acute care teaching and research hospital located in northwest Washington, D.C. In fiscal year 2015, MedStar Georgetown had 16,678 inpatient admissions, and 672,925 outpatient visits including 34,248 emergency visits

MedStar Georgetown University Hospital's largest program is the provision of acute hospital services to the communities of the northwest Washington, D.C. and the surrounding areas. In addition to the program service expenses listed above, MedStar Georgetown incurred \$188.5M of management and general expenses in providing services to its communities. MedStar Georgetown's centers of excellence include neurosciences, transplantation, cancer, and gastroenterology. The hospital is one of a few centers in the world providing living-donor liver transplantation. MedStar Georgetown's neurosciences program is recognized as an Advanced Primary Stroke Center by The Joint Commission and is a National Parkinson Foundation Center of Excellence for Parkinson's disease and other movement disorders. MedStar Georgetown's Lombardi Comprehensive Cancer Center is one of only 41 centers in the U.S., and the only one designated as a Comprehensive Cancer Center by the National Cancer Institute in Washington, D.C. MedStar Georgetown was the first hospital in Washington, D.C. to attain Magnet Recognition by the American Nurses Credentialing Center (ANCC), and one of only 71 hospitals nationwide to achieve three magnet designations (2004, 2008, 2014). The hospital was the recipient of the 2013 Delmarva Foundation for Medical Care's Excellence Award for Quality Improvement in Hospitals.

MedStar Georgetown University Hospital provided \$75.6M in health professions education in fiscal year 2015. This category includes training in graduate medical education, and education for physicians, medical students, nurses, and other health professions.

MedStar Georgetown University Hospital provided \$50.8M in subsidized (mission driven) health services in fiscal year 2015. These critical services, which are driven by community needs, operate at a loss. They address priorities primarily through disease prevention and improvement of health status. Services provided include outpatient primary care services, pediatrics, and cancer services.










