The LifeFlight Foundation (LFF) supports the services and provision of emergent medical care and transportation to critically ill and injured patients through LifeFlight of Maine (LOM) LFF provides capital support for aircraft acquisition, specialized medical equipment used on LOM helicopters and ground ambulances, emergency aviation infrastructure improvements such as hospital helipads, automated weather systems, and low level instrument flight infrastructure, and, support for a statewide High Fidelity Simulation continuing medical education provided by LOM to physicians, physician extenders, nurses, paramedics, and emergency medical technicians

The LFF supports a wide range of continuing medical education In 2014 LFF provided financial and management support for the human patient simulator project run by LOM in partnership with the Maine Department of Public Safety Emergency Medical Services Bureau The simulation program is used by hospitals and EMS agencies throughout Maine for continuing medical education to improve the care of critically ill and injured patients with a special focus on children In 2014, the Foundation helped to support LifeFlight in the provision of 27 HPS programs for 196 physicians, Nurse Practitioners/PAs, emergency department and ICU RNs, Respiratory Therapists, Paramedics, and emergency medical technicians In addition, the Foundation, working with LifeFlight and Pediatric Intensive Care Unit physicians from Maine Medical Center and Eastern Maine Medical center, supported 3-day long conferences at hospitals focused on the care of critically ill and injured hospitals with for 65 Emergency Physicians, Nurses, and hospital based paramedics Furthermore, the Foundation supported over 20 public education events
