ISIS AND OSIRIS ARE SENT TO MEMBERS, CONSISTING OF OVER 3,000 INDIVIDUALS AND INSTITUTIONS.

THE ENTRIES ARE ALSO LOADED INTO THE HISTORY OF SCIENCE, TECHNOLOGY, AND MEDICINE (HSTM) DATABASE. STEPHEN WELDON HAS SERVED AS THE SOCIETY'S BIBLIOGRAPHER FOR 12 YEARS. STEPHEN IS BASED AT THE UNIVERSITY OF OKLAHOMA, WHERE HE ALSO SERVES AS A MEMBER OF THE HISTORY OF SCIENCE FACULTY.
