THE FISCAL YEAR JULY 1, 2014 - JUNE 30, 2015, GRAFTON PROVIDED TREATMENT AND DAILY LIVING SUPPORT TO INDIVIDUALS WITH DEVELOPMENTAL, INTELLECTUAL AND PSYCHIATRIC DISABILITIES. OUR TRAUMA INFORMED SERVICES ARE DESIGNED TO INCREASE OUR CLIENTS' FUNCTIONAL AUTONOMY - IN SHORT WE SEEK TO GIVE PEOPLE THEIR LIVES BACK. MANY OF OUR CONSUMERS HAVE ATTEMPTED LESS INTENSIVE PROGRAMS IN THE PAST, AND REQUIRE OUR INDUSTRY-LEADING EDUCATIONAL, THERAPEUTIC AND RESIDENTIAL SERVICES. THESE INDIVIDUALS WERE DIAGNOSED AS HAVING AUTISM, INTELLECTUAL DISABILITIES, PSYCHIATRIC DISORDERS, LEARNING DISABILITIES, SENSORY AND MEDICAL CHALLENGES -- ALMOST ALL HAVE COMORBID PSYCHIATRIC AND DEVELOPMENTAL DISABILITY. 98 LOCAL GOVERNMENTS REFER OUR CONSUMERS FROM VIRGINIA, MARYLAND, WEST VIRGINIA, AND THE DISTRICT OF COLUMBIA. GRAFTON PROVIDED RESIDENTIAL TREATMENT TO 428 CHILDREN/ADOLESCENTS AND 99 ADULTS, AS WELL AS EDUCATION/DAY SUPPORT SERVICES TO 521 CHILDREN/ADOLESCENTS AND 75 ADULTS WITHIN THREE MAIN GEOGRAPHIC REGIONS: WINCHESTER/BERRYVILLE, VA, LEESBURG/STERLING, VA, AND RICHMOND, VA. SERVICES WERE ALSO PROVIDED IN BRADENTON, FLORIDA AND CHARLESTOWN WEST VIRGINIA. IN 2014 GRAFTON BECAME A SHAREHOLDER IN A SUBSIDIARY CORPORATION LOCATED IN SOUTH RIDING VIRGINIA, PROVIDING OUTPATIENT PSYCHOTHERAPY SERVICES. ADDITIONALLY, GRAFTON PARTNERS WITH THE CITY OF WINCHESTER TO PROVIDE SERVICES TO THE INFANT AND TODDLER CONNECTION OF THE SHENANDOAH VALLEY. THIS SERVICE TEACHES, COACHES AND MENTORS FAMILIES OF CHILDREN UP TO AGE THREE WHO HAVE A DEVELOPMENTAL DELAY OR DIAGNOSED DISABLING CONDITION. DURING THIS FISCAL YEAR APPROXIMATELY 592 INFANTS/TODDLERS RECEIVED EARLY INTERVENTION SERVICES AND SUPPORTS IN THE CITY OF WINCHESTER, VA AND THE COUNTIES OF FREDERICK, CLARKE, WARREN, PAGE, AND SHENANDOAH, VA. IN 2012 GRAFTON EXPANDED ITS SERVICE OFFERINGS AND LAUNCHED AN APPLIED BEHAVIORAL ANALYSIS PROGRAM THAT PROVIDED THERAPEUTIC SUPPORTS TO 216 CHILDREN WITH AUTISM AND THEIR FAMILIES IN THEIR HOMES OR OTHER NATURAL SETTINGS DURING THE FISCAL YEAR. THESE SERVICES WERE PROVIDED IN FIVE MAIN GEOGRAPHICAL AREAS: SHENANDOAH VALLEY, VA, RICHMOND, VA, , NORTHERN VIRGINIA, CHARLES TOWN/JEFFERSON COUNTY, WV, AND BRADENTON/MANATEE COUNTY, FL. ON FEBRUARY 5, 2013 GRAFTON INTEGRATED HEALTH NETWORK BECAME THE SOLE MEMBER OF GRAFTON AUSTRALIA, LTD. GRAFTON AUSTRALIA, LTD WAS AN AUSTRALIAN NOT FOR PROFIT CORPORATION THAT HAD STATUS AS A PUBLIC BENEVOLENT INSTITUTION SUPPORTING INDIVIDUALS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES IN AUSTRALIA. SERVICES INCLUDED CONSULTATION, SUPPORT, RESEARCH, AND EDUCATION TO INDIVIDUALS WITH ID/DD DISABILITIES AND THEIR FAMILIES. GRAFTON ALSO PROVIDED CONSULTATIVE SERVICES IN CALIFORNIA AND ALABAMA IN RELATION TO THE GRAFTON METHOD, TRAUMA INFORMED CARE, AND THE ELIMINATION OF RESTRAINTS. IN SUPPORT OF ITS MISSION, GRAFTON EMPLOYED APPROXIMATELY 760 FULL TIME EQUIVALENT STAFF, OF WHICH APPROXIMATELY 85% ARE EMPLOYED IN THEIR CORE SERVICES (WHICH OPERATES 24-HOURS PER DAY, SEVEN DAYS PER WEEK, 365 DAYS PER YEAR).
