The Neighborhood Stabilization Program (NSP) is a Federal program administered by HUD through local jurisdictions for the purpose of stabilizing communities that experienced a high number of foreclosures. The organization was approved as a sub-grantee from the Commonwealth of Virginia in late 2009 and has acquired and rehabbed 18 homes in the approved census tracts of Prince William County. Of the 18 homes, 17 have now been sold to eligible buyers. The 18th home is under a lease-to-purchase contract. More than half of the buyers have had incomes of less than 50% of the area median income. Three NSP homes were sold during FY 2015. The NSP homes are providing homes to 63 adults and children.

Rental Properties CFH owns and manages 18 rental units to provide homes to the local workforce with low to moderate incomes. CFH acquired 7 Community Benefit Units at The Grove at Arlington in 2008 and continues to manage these units in accordance with Arlington County's Affordable Dwelling Unit Ordinance. In 2009, CFH acquired 2 units in Charleston Square in Fairfax and continues to manage these affordable dwelling units in accordance with Fairfax County's Affordable Dwelling Unit Ordinance. In 2008, CFH built a duplex in Fredericksburg and in 2012 acquired 7 single family detached homes also in Fredericksburg. The Fredericksburg units are not designated as Affordable Dwelling Units but are rented to households with low-to-moderate incomes. CFH is currently managing one lease-to-purchase unit under the guidance of the NSP program. CFH continues to co-own its initial rental project of 30 apartments in Vienna. The CFH rental program provided permanent rental homes to 175 adults and children during FY 2015.

King George County - the Organization purchased land in 2009 with the intent to develop 14 townhomes and sell them to County employee per a proffer agreement. The Organization made a determination in fiscal year ended June 30, 2015 that the value of the land had decreased and wrote down the carrying costs. An expense was recorded in the amount of \$224,326.
