THE RAPPAHANNOCK FOUNDATION FOR THE ARTS PRODUCES PERFORMING ARTS GROUPS FOR THE CULTURAL ENRICHMENT OF THE COMMUNITY. DURING THE FISCAL YEAR ENDED JUNE 30, 2015, FIVE SHOWS WERE STAGED BY THE RFA WORKING ALONE. 2,161 PERSONS ATTENDED THESE SHOWS, AND 61 PERSONS PERFORMED AT THEM. THE VENUE FOR THESE SHOWS WAS SOLD OUT FOR TWO PERFORMANCES. THE OTHER THREE WERE AT 80% CAPACITY. IN ADDITION, THE RFA CO-SPONSORED TWO EVENTS, WITH ANOTHER 737 IN ATTENDANCE. THESE PRODUCTIONS BROUGHT ORCHESTRAL MUSIC, JAZZ, BALLET, AND TWO FOLK MUSIC GROUPS TO THE AREA. NO OTHER LOCAL AREA ORGANIZATION STAGED PRODUCTIONS OF A COMPARABLE QUALITY, OR ENABLED AS MANY RESIDENTS TO ENJOY THESE KINDS OF PERFORMING ARTS.

THE RAPPAHANNOCK FOUNDATION MADE GRANTS TO AREA ORGANIZATIONS THAT SUPPORT THE PERFORMING ARTS. TEN GRANTS WERE MADE DURING THE FISCAL YEAR. 10,802 PERSONS ATTENDED THE PERFORMANCES MADE POSSIBLE BY THESE GRANTS, AND ANOTHER 1,363 PERSONS PERFORMED AT THEM. THESE PRODUCTIONS INCLUDED MUSIC, VISUAL ARTS, AND DRAMA.

DURING THE FISCAL YEAR, 12 SHOWS WERE STAGED FOR 4,178 STUDENTS. AGE-APPROPRIATE ARTISTS PERFORMED DRAMA, HISTORICAL EVENT RECOUNTING, INTRODUCED WEST AFRICAN CULTURE AND DANCE, AND PERFORMED SEVERAL DIFFERENT MUSIC STYLES. THESE SHOWS WERE DESIGNED TO REINFORCE THE STATE EDUCATIONAL STANDARDS OF LEARNING.
