FOOD AND BASIC NEEDS - (PINE RIDGE AND CHEYENNE RIVER SIOUX INDIAN RESERVATIONS IN SOUTH DAKOTA, MENOMINEE INDIAN RESERVATION IN WISCONSIN) - AMERICAN INDIAN KIDS FACE SOME OF THE WORST POVERTY IN THE NATION ZIEBACH COUNTY, ON THE CHEYENNE RIVER SIOUX INDIAN RESERVATION HAS THE HIGHEST CHILD POVERTY IN THE UNITED STATES OGLALA LAKOTA COUNTY (FORMERLY SHANNON COUNTY), ON THE PINE RIDGE INDIAN RESERVATION, HAS THE HIGHEST MORTALITY RATE IN THE NATION IT IS HARD FOR A CHILD TO SUCCEED IN SCHOOL IF THEY ARE COLD, HUNGRY, OR DON'T HAVE THE SCHOOL SUPPLIES THEY NEED (SEE SCHEDULE O FOR CONTINUATION)FOOD REMAINS A RUNNING STRONG PRIORITY AS WE WORK HARD TO FEED CHILDREN WHO MAY OTHERWISE GO HUNGRY RUNNING STRONG DONATED 227,600 LBS OF FOOD TO FEED FAMILIES ON THE PINE RIDGE AND CHEYENNE RIVER SIOUX INDIAN RESERVATIONS ALONG WITH 3,008 TURKEYS AND FOR THANKSGIVING AND CHRISTMAS AS PART OF OUR BACKPACK FOOD PROGRAM, WE DONATE SACKS FILLED WITH FOOD TO TAKINI SCHOOL CHILDREN OVER WEEKENDS AND SCHOOL BREAKS WHEN THEY DO NOT HAVE ACCESS TO FREE SCHOOL LUNCHES AND BREAKFASTS (12,960 SACKS OF FOOD DISTRIBUTED) WE ALSO SUPPORT A BACKPACK FOOD PROGRAM MENOMINEE INDIAN RESERVATION IN WISCONSIN, SERVING HEALTHY "SMART SACKS" FOR THE ENTIRE KESHENA PRIMARY SCHOOL (4 YEAR OLD PRE-K - 5TH GRADE STUDENTS (13,950 SACKS OF FOOD) KIDS WERE NOT ONLY KEPT FROM BEING HUNGRY, THEY LEARNED ABOUT NUTRITION AND EXERCISE AS PART OF A COMPREHENSIVE PROGRAM TO ENCOURAGE HEALTHY LIFE CHOICES ALONG WITH DURING THE SCHOOL YEAR, RUNNING STRONG SERVED A HEALTHY SACK LUNCH TO CHEYENNE RIVER KIDS IN FOUR COMMUNITIES SO THAT THESE KIDS HAVE SOMETHING TO EAT DURING THEIR SUMMER VACATION THIS SUMMER FOOD PROGRAM SERVED 6,456 MEALS (A 22% INCREASE OVER THE PREVIOUS YEAR) TO CHILDREN AT 4 SITES OVER 11 WEEKS, AVERAGING 120 KIDS SERVED PER DAY) RUNNING STRONG ALSO PROVIDED FUNDS YEAR-ROUND TO PURCHASE MEAT AND FRUIT AND VEGETABLES FOR KIDS WHO CAME TO THE CHEYENNE RIVER YOUTH PROJECT IN ADDITION TO HEALTHY MEALS AND FOOD, IN FY15, RUNNING STRONG ALSO DISTRIBUTED THE FOLLOWING NEW ITEMS TO HELP NEEDY AMERICAN INDIAN CHILDREN 2,875 NEW BACKPACKS FILLED WITH SCHOOL SUPPLIES (24 CT CRAYONS, ERASER, GLUE STICK, NOTEBOOK, PEN, NO 2 PENCILS, RULER, PENCIL SHARPENER, 5"SCISSORS, PAPER) FOR ELEMENTARY SCHOOL STUDENTS, 2,885 BACKPACKS FILLED WITH SCHOOL SUPPLIES (2 POCKET FOLDERS, NOTEBOOKS, LOOSE LEAF PAPER, ERASERS, COLORED PENCILS, PROTRACTORS, GLUE STICKS, NO 2 PENCILS, RULER, HIGHLIGHTERS, RED & BLACK PENS, CALCULATOR) FOR JR HIGH AND HIGH SCHOOL STUDENTS, 2,150 NEW ADULT COATS WITH HOODS, 2,684 NEW CHILDREN'S COATS WITH HOODS, 2,419 NEW CHILDREN'S WINTER HATS, 2,369 NEW CHILDREN'S WINTER SCARVES, 2,459 NEW CHILDREN'S WINTER GLOVES, 2,678 NEW FLEECE JACKETS, 2,108 NEW TOYS FOR CHRISTMAS, 1,320 NEW HYGIENE KITS CONTAINING TOOTHBRUSH, TOOTHPASTE , 509 NEW BASKETBALLS, 1,791 PAIRS OF NEW SHOES, 1,820 NEW BLANKETS, 1,016 BOXES OF ALL LAUNDRY DETERGENT, 11,172 BARS OF DOVE SOAP AND 44,280 DIAPERS ALONG WITH DIRECTLY TO FAMILIES ON PINE RIDGE AND CHEYENNE RIVER, RUNNING STRONG ALSO DONATED THESE BRAND NEW ITEMS TO MEET BASIC NEEDS TO 23 SMALL GROUPS ACROSS THE COUNTRY, A 26% INCREASE IN GROUPS OVER THE PREVIOUS YEAR THESE YOUTH PROGRAMS INCLUDED OFFICE OF DINE YOUTH, THREE PRECIOUS MIRACLES AND TODAY WE FOLLOW, TOMORROW WE LEAD IN ARIZONA, AMERICAN INDIAN RECRUITMENT PROGRAM IN CALIFORNIA, DENVER INDIAN CENTER AND DENVER INDIAN FAMILY RESOURCE CENTER IN COLORADO, INDIAN YOUTH OF AMERICA IN IOWA, NEZ PERCE TRIBAL SOCIAL SERVICES IN IDAHO, DEPARTMENT OF INDIAN WORK IN MINNESOTA, BOYS & GIRLS CLUB OF THE NORTHERN CHEYENNE NATION IN MONTANA, SACRED PIPE RESOURCE CENTER AND YOUTHWORKS IN NORTH DAKOTA, CAPACITY BUILDERS AND GLOBAL RUNNING CULTURE IN NEW MEXICO, BRUSHY CHEROKEE ACTION ASSOCIATION, EUCHEE (YUCHI) LANGUAGE PROJECT AND FELLOWSHIP OF AMERICAN INDIANS IN OKLAHOMA, WISDOM OF THE ELDERS IN OREGON, THE CHEYENNE RIVER YOUTH PROJECT, TAKINI SCHOOL, CHEYENNE-EAGLE BUTTE SCHOOL AND SUMMIT SCHOOL DISTRICT IN SOUTH DAKOTA, AND THE HAYWARD COMMUNITY SCHOOLS AND MENOMINEE INDIAN SCHOOL DISTRICT IN WISCONSIN TO STRETCH DOLLARS DURING THE NORTHERN PLAINS WINTER, OUR EMERGENCY HEAT MATCH PROVIDED HEATING ASSISTANCE TO 478 PINE RIDGE FAMILIES (\$100 MATCH PER FAMILY) AND TO 231 CHEYENNE RIVER YOUTH PROJECT MEMBER FAMILIES AND HELPED KEEP TWO YOUTH CENTERS DOORS OPEN (307 FAMILIES SERVED IN FAMILY SERVICES IN 2015/1,336 UNDUPLICATED KIDS)
