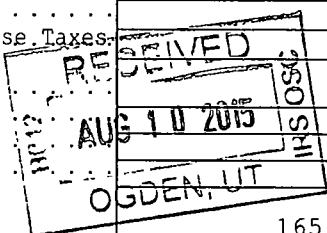

The securities consist solely of 249,552 shares of the common stock of Old Point Financial Corporation, a publicly traded company. The value on line 1 reflects a 10% blockage discount due to the size of the block of stock owned (over 5%, but less than 10% of the outstanding shares of the company) the size of the block relative to recent trading volume (several years worth of trades), the lack of any known unsatisfied demand for shares of the company stock and other factors. By letter dated October 7, 2013, Davenport & Company, LLC expressed their opinion that based on the size of the block of stock and market conditions, as of June 30, 2013, a price concession of 10% or more would be required to induce a willing and knowledgeable buyer to acquire the shares.
