The Richmond Ballet is one of Virginia's finest arts and education institutions and has gained national and international acclaim as a premier dance organization. This year, over 30,000 people in and around the Richmond, VA area were entertained by four repertory performances as well as full length productions of the "Nutcracker" and "Don Quixote". The Ballet also traveled to China for 2 weeks performing in 4 different cities for approximately 7,300 people.

The School of Richmond Ballet provides dance classes (ballet, jazz, modern, theater dance, and character) for over 600 students age 3 to adult. The school also provides advanced training for qualified students who perform with the Ballet's professional dance troupe.

In its 21st year, this educational outreach program provides year-long in-school classes teaching fourth graders discipline, dedication and self-awareness through dance. In the city of Richmond and surrounding counties, as well as Charlottesville, 25 schools participated in the program. A 2 week residency was also conducted in Israel. The students perform on stage at the end of each school year.
