At that time, all students were removed from the school by the West Virginia Department of Health and Human Resources. In proceedings following this incident, and by agreement with the above named department, it has been determined best for the school to relocate in another state. The process is still ongoing. Meanwhile, the present campus has been maintained until it can be sold and another location established. We plan to reopen as soon as a new location is secured and facilities are in place to accept boarding students once again.
