The drug prevention program at the Brooke Hancock Family Resource Network works towards reducing substance abuse in Brooke and Hancock counties through prevention focused on youth and families We provide educational resources, evidence-based prevention education to local schools, and maintain a library of prevention materials for distribution throughout the community to promote an alcohol and drug free life style These initiatives are made possible by working with the federal Drug Free Communities and the statewide Substance Abuse Prevention programs An estimated 40,000 residents have heard or seen our messages though local media campaigns including television spots, radio spots, billboards, and newspaper inserts We support youth initiatives by hosting a local RAZE Crew, a youth lead anti-tobacco program consisting of 11 current members, in addition to supporting other Crews in the community
