THE PROGRAM PROVIDES LOW-INCOME FAMILIES ACCESS TO SERVICES THAT PROMOTE SELF-SUFFICIENCY. THE PROGRAM OFFERS EDUCATION AND EARLY CHILDHOOD DEVELOPMENT, COMPREHENSIVE HEALTH CARE PROGRAMMING, PARENT INVOLVEMENT PROGRAMMING, AND FAMILY SERVICES.
