OUR 12 HEALTH CENTERS IN NORTH CAROLINA, SOUTH CAROLINA, VIRGINIA AND WEST VIRGINIA PROVIDE FAMILY PLANNING SERVICES TO PREVENT UNINTENDED PREGNANCIES AND SEXUALLY TRANSMITTED INFECTIONS (STIS). WE OFFER STI TESTING AND TREATMENT THAT PREVENT THE SPREAD OF CONTAGIONS THAT CAN CAUSE INFERTILITY, CANCER AND DEATH. WE OFFER IMMUNIZATIONS TO PROTECT FROM COMMUNICABLE DISEASES. WE PROVIDE BREAST AND CERVICAL CANCER SCREENINGS. SURGICAL AND MEDICATION ABORTION ARE PROVIDED AT SEVERAL OF OUR HEALTH CENTERS. WE STRESS ABSTINENCE AND INFORMED DECISION MAKING AS THE MOST EFFECTIVE MEANS OF PROTECTION AND WE PROVIDE MEDICALLY ACCURATE INFORMATION ON BIRTH CONTROL AND DISEASE PREVENTION.
