The organization builds and sells homes to families in need. Construction and sale of 14 homes were completed during the fiscal year ending June 30, 2015. Persons served totaled 23 adults and 27 children. Of these homes, 7 were headed by females, and 1 was headed by a Latino. Four homes (28%) of the families were below 50% of the median income and 72% (10 homes) were below 70% of the median income. One home had a disabled family member, 6 families included African-American members, and 1 family was of Asian descent. Five homes were headed by a single parent.

The organization also preserved existing homes through the repair of 35 homes and 1 school room. This includes the homes of 4 veteran, 4 disabled, 28 elderly, and 18 households headed by females. Two families were below 25% of the median income, 22 households were below 50% of the median income, and 11 households were below 70% of the median income.

Work in progress at June 30, 2015 included 15 homes and 3 home repair projects.

For the fiscal year ended June 30, 2015, 1,921 volunteers donated 61,162 hours of time.

Wage and salary increases are presented in total and by department to the Board of Directors for approval along with the annual budget. Periodically, the compensation plan is tested against information from a regional service bureau to ensure that wages and salaries are reasonable for the western North Carolina region. A report of this test is reviewed by the Board of Directors and was last made during the year ending June 30, 2007.**
