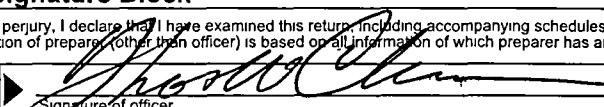

NBCC Minority Fellowship Program, through which twenty-three
doctoral students in counseling received \$20,000 education awards,
40 master's mental health counseling students received \$5000 and 28
master's substance abuse counseling students receive \$11,000. The
Foundation provides training assistance, mentors and networking
opportunities to enable them to successfully complete their programs,
and take leadership roles in reducing the disparities in mental health
care for minority populations.

The Foundation supports efforts to build the capacity of communities
to provide mental health care through 2 primary initiatives:
implementation of the NBCC Mental Health Facilitator program, and

To date, the NBCC Foundation has supported the implementation of the
Mental Health Facilitator program in several countries, and ongoing
to support to the programs in Bhutan, Malawi, Malaysia and Mexico;
has provided counseling education materials free of charge to Cambodia,
Malawi, Nigeria, Portugal, and Romania; and training and technical
assistance in Jacksonville, FL.

Annually, the Foundation awards scholarships to individuals who are
pursuing careers in professional counseling, and who commit to serving
