North Carolina Pre-Kindergarten Program (NC Pre-K) - Program provides high-quality pre-kindergarten services to at-risk 4 year olds to better prepare them for school success. The Partnership serves as the designated administrative agency for the Beaufort County NC Pre-K contract. Served 132 slots in 14 classrooms in Beaufort County Public Schools, local child care centers and Head Start. 12 of the children were identified as having a disability and received services for that disability prior to entering kindergarten

4b (Code:) (Expenses \$ 179,789 including grants of \$ 9,218) (Revenue \$ 7,101)

Quality Enhancement/Maintenance (QE) - This program offers on-site technical assistance to all child care providers in Beaufort and Hyde counties who wish to increase their star rating or maintain their 4 or 5 star ratings. Assistance includes a mock environmental rating scale, quality training/workshops including CSEFEL and start up technical assistance for new providers. This program also provides maintenance of a resource library and non-cash school supply vendor gift cards for facilities that raised their star level to a 4 or 5 star license or maintained their 4 or 5 star license as funding is available. 220 child care providers attended trainings. 39 child care facilities including 4 in Hyde County requested and received technical assistance. 9 child care facilities participated in technical assistance activities designed to increase their star rating to a 4-star or higher, and 9 child care facilities participated in technical assistance activities designed to maintain their star rating of a 4-star or higher. 46 parents checked out items from the resource lending library. 80% of licensed child care facilities in Hyde County and 58% of licensed child care facilities in Beaufort County have a 4-star rated license or higher (does not include 4 GS-110 licensed facilities)

4c (Code:) (Expenses \$ 152,853 including grants of \$ 18,295) (Revenue \$)

Child Care Health Consultant (CCHC) - This program provides health consultations to child care providers in licensed child care centers and homes to include review and training on health policies and procedures, health/developmental screenings on a limited basis based on child care provider concern or if CCHC observation indicates a need, review of immunizations, and educational programs/trainings to providers, children and parents. Trainings are to include but not limited to Infant/Toddler Safe Sleep-Sudden Infant Death Syndrome, Emergency Preparedness, Medication Administration, etc. The CCHC provides the Nutrition and Physical Activity Self Assessment for Child Care (NAP SACC) program for up to eight facilities. The CCHC works with the other Partnership staff on trainings and child care quality issues. 17 facilities received on-site consultations, 31 on-site visits, and 62 child care providers participated in trainings. The CCHC also coordinates the Beyond the POD (Preventing Obesity by Design) project at the two child care facilities. The project is intended to prevent young children from becoming obese and to promote a healthy lifestyle for families. The project is also transforming their Outdoor Learning Environments to increase physical activity and nutrition opportunities
