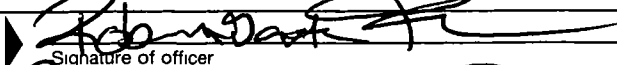
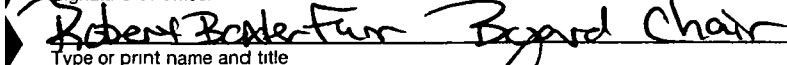

The NC Pre-Kindergarten Program is a state-funded community based, voluntary pre-kindergarten initiative designed to prepare at-risk 4 year olds in North Carolina for success in school. All NCPK classrooms provide high quality standards using Creative Curriculum which focuses on preparing children in developmentally appropriate ways to be successful students.

4b (Code:) (Expenses \$ 198508 including grants of \$ 198508) (Revenue \$)

Parent Child Interaction Therapy (PCIT) will provide the foundation for mental health treatment of these referred children and their families and will reduce, over time, the incidence of child maltreatment and recidivism of families referred to DSS. PCIT is an evidenced based behavioral parent training model in which parents receive live coaching from trained clinicians. It has a 2 pronged approach focusing on the attachment of the child and parent, and then on the effective discipline of the child. Capacity for mental health and comprehensive clinical trauma assessment of young children will be established, through training clinicians in Parent Child Interaction Therapy (PCIT) to serve children 2- age 5 and their parents/caregivers so that families have a choice about where to receive mental health services. Up to twelve clinicians will be selected from Cabarrus County (including Safe Alliance) to participate in a 9-12 month learning collaborative with the NC Child Treatment Program and the Center for Child and Family Health faculty to seek being rostered as a PCIT Clinician in NC upon completion of the training.

4c (Code:) (Expenses \$ 159638 including grants of \$ 159638) (Revenue \$)

The Building Healthy Lifestyles activity is a multi faceted approach to reduce childhood obesity in Cabarrus County. One contracted program manager and up to 0.5 FTE Assistant will implement the following: NAP-SACC, Color Me Healthy, Healthy Futures in the Kitchen, as well as hold several community focus groups with parents. NAP-SACC will be implemented in select licensed child care centers that accept subsidized children to assess their policies, practices, and environments around nutrition and physical activity. Centers will receive related training and technical assistance based on the needs identified in the assessment. The Color Me Healthy curriculum may be provided by contracted services and may be implemented in these participating centers with children ages 4 to 5 to teach them that healthy food and physical activity are fun through the use of color, music, and exploration of the senses. Healthy Futures in the Kitchen will be contracted through CPCC College of Culinary Arts and supported by a Consultant from Johnson & Wales University to educate childcare administrators and cooks how to prepare healthy meals that comply with The Child and Adult Care Food Program guidelines and that appeal to young children. The program also teaches basic nutrition education and food preparation skills. Up to 6 focus groups will be held to identify the barriers to healthy eating and physical activity facing parents. Smart Start funds may also support related trainings, materials, travel, stipends, UNCC research analysis, and indirect costs.
