Additionally, three free concerns were performed with the Contemporary Arts Museum of Houston in conjunction with exhibits. Free public park performances were also provided to the community as well as two performances at Hobby Airport.

Free outreach programs that were performed for approximately 6000 public school children at Zilka Hall. These students also participated in free in-school preparatory workshops to enrich the performance programming. Additionally, about 200 students participated in the in-school residency program with our teaching artists. The curriculum for these residencies is designed in collaboration with the schools as a supplement to the academic curriculum.
