UNDER THE TERMS OF THE AGREEMENT, GABLES OWNS, MANAGES AND MAINTAINS THE STRUCTURES AND FACILITIES IT DEVELOPS ON OGLETHORPE'S LAND AND OGLETHORPE WILL HAVE THE OPPORTUNITY TO RESERVE AVAILABLE APARTMENT UNITS FOR ITS RESIDENTIAL STUDENTS THAT CHOOSE TO LEASE FROM GABLES AT THEN EXISTING MARKET RATES. GABLES PAID OGLETHORPE \$11,675,000 IN NON-REFUNDABLE CASH CONSIDERATION IN THREE INSTALLMENTS FROM AUGUST TO NOVEMBER 2014. OF THIS TOTAL, OGLETHORPE ELECTED TO ADD \$11 MILLION TO ITS ENDOWMENT INVESTMENTS AND USE \$675,000 FOR A VARIETY OF CAMPUS IMPROVEMENTS.
