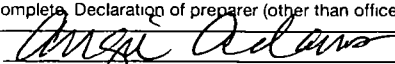

Thanks to generous PENCIL Partners and individuals who donate new items like notebook paper, pencils and glue sticks, teachers can ensure their classrooms are stocked and students can focus on learning.

Each of PENCIL's six Family Resource Centers serves as a hub of community support and resources for students and their families. With support from PENCIL Partners and other organizations, the FRCs offer academic enrichment, literacy instruction, health information, character development, financial counseling, student support groups, teen-mom support groups and much more. The FRCs also stock supplies to meet basic needs such as standard school attire, school supplies, nonperishable food items, hygiene items and baby supply items.

Nashville After Zone Alliance (NAZA) is a network of afterschool providers that operate in different geographic zones across Nashville. PENCIL is the coordinating agency for both the South Central and McGavock Zones. The goal of NAZA is to create a coordinated network of quality afterschool programs where students experience enrichment activities, receive individualized academic assistance, participate in teambuilding and leadership skills as well as explore a wide range of career opportunities.

With the help of nearly 900 businesses, community groups, non-profits and communities of faith now connected to Nashville Public Schools through PENCIL, essential programs vital to students have been created. We engage tutors and mentors, help families with social services, administer after-school programs for middle school students and engage at-risk high school students in a school-to-career program of study for academic credit. PENCIL is one of the largest and most successful examples of school-community involvement in the country. During 2014-15, over 13,000 volunteers contributed nearly 145,000 hours of service in our schools with an in-kind value of \$3.3 million.

PENCIL's form 990 is reviewed annually by members of PENCIL's Finance Committee, an active subcommittee of PENCIL's Board of Directors. The Finance Committee is chaired by the Board Treasurer and the Vice President of Finance serves as the assigned staff person.

The annual performance review of the President is conducted each year by a combination of the current year's Board Chair and the prior year's Board Chair.

The President's salary is evaluated annually by use of data provided by Nashville-based Center for Nonprofit Management for similarly qualified persons serving in the President's role within nonprofit organizations of similar size and scope of services provided. During fiscal year 2014, all PENCIL staff positions were evaluated and a compensation study conducted by Cushion Employment Services Group.
