THE EXTENSION IS A NON-PROFIT, COMMUNITY SUPPORTED ORGANIZATION REACHING PEOPLE IN NEED OF RECOVERY FROM ALCOHOL AND DRUG ADDICTION. IT HELPS FACILITATE THE INDEPENDENCE OF THOSE SEEKING HELP THROUGH A RESIDENTIAL PROGRAM FOR THE HOMELESS, OUTPATIENT COUNSELLING SERVICES FOR LOW AND MODERATE INCOME INDIVIDUALS AND OUTREACH THROUGH EMERGENCY WINTER SHELTER PROGRAM. IN YEAR 2015 IT SERVED 229 MEN AND WOMEN IN ITS RESIDENTIAL PROGRAM. OF THOSE, 76 BECAME ACTIVE FAMILY MEMBERS EVIDENCED BY THEIR TAKING FINANCIAL RESPONSIBILITY FOR THEIR CHILDREN AND SPENDING QUALITY TIME WITH THEM. 66 SUCCESSFULLY TRANSITIONED TO INDEPENDENT LIVING AND 64 REMAINED IN THE PROGRAM AT YEAR'S END. DURING 2015, IT HAD 124 GUESTS IN THE WINTER PROGRAM, WITH A TOTAL OF 895 BED NIGHTS (NUMBER OF RESIDENTS X THE NUMBER OF NIGHTS THEY STAYED). FOR ALL PROGRAMS, APPROXIMATELY 920 VOLUNTEERS GAVE 7,592 HOURS AND PROVIDED 50,112 MEALS.
