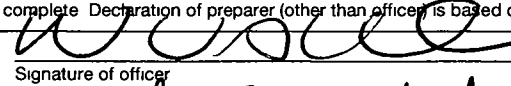

Youth V.I.B.E. (Vision, Industry, Business, Empowerment.) was created in 1996. In the 18-years since its inception, Youth V.I.B.E. has been a provider of youth development programs for high school aged youth, 14 to 18 years. Youth V.I.B.E., Inc. has grown into a self-sustaining, community-supported and effective organization. And has served thousands of youth in the Atlanta Metro-area. Comparing Youth V.I.B.E. nationally to other non-profits providing youth services, through United Way's Program Quality Assessment Youth V.I.B.E. ranks above average in the following categories: Providing a supportive environment, Participant Interaction, Participant Engagement Creating youth centered policies and practices, Establishing high expectations for youth and staff, and Providing access through staff longevity, student-teacher ratio, communication with families and students

Youth V.I.B.E.'s Afterschool programming is held on the school site Mondays - Thursdays throughout the school year between 3:30 -6:30 pm. The afterschool program offers students free academic tutorials/homework assistance, mentoring and workforce development skills. All afterschool programming is offered to qualifying students for free or reduced based on income.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)Youth V.I.B.E.'s food program at Mohammed Schools of Atlanta serves 90% of the students with free or reduced Halal meals.

Over the last three years of providing food services to Mohammed Schools of Atlanta, Youth V.I.B.E. has received acclaim from the students and staff. Youth V.I.B.E. is a as USDA Food Sponsor and has provided 10 school sites free meals for over 1,100 youth in addition to the Food Service Program at Mohammed Schools of Atlanta. Those Halal meals included breakfast, snack, lunch and dinner (dinner served only during the summer program). Youth V.I.B.E. has successfully served over 90,000 meals and has now incorporated food service to Mohammed Schools year round. At Mohammed Schools, we have acquired kitchen equipment, hire serve safe cooks and provide healthy, Halal meals for breakfast, lunch and after school snacks. Our food service program uns from 7:15 am - 4:15pm Monday - Friday throughout the school year.
