Instructional services to graduate and undergraduate students. Barry University offers more than 100 undergraduate, graduate, professional, and doctoral programs to approximately 9,000 full and part-time students at multiple sites through the state of Florida.

Student services and auxiliary enterprises. The student affairs division of Barry University adheres to the philosophy that students succeed when all aspects of their development are at optimum level. To this end, the Student Affairs staff stands ready to serve as a support system for Barry students. The services available include the bookstore, campus ministry, career services, commuter student affairs, leadership and transition, commencement, counseling and psychological, dining, disability, health, intercultural center, public safety, residential life, student activities, student union, and volunteer and community services.

Academic support. Barry University offers academic support to students as it relates to library, computer, and learning center support. The Monsignor William Barry Memorial Library includes more than 950,000 items, over 40,000 print and on-line journal subscriptions and several thousand on-line books and streaming video resources. A significant strength is the excellent Roman Catholic research materials collection. The Barry Library Information Services System Web (BLISSWeb) is the computerized online catalog of the library's holdings. BLISSWeb can be searched from terminals and computers in the library, computer labs, dorms, and offices across campus as well as at home and off-campus sites. The Library is a member of SEFLIN (South East Florida Library Information Network), the Online Computer Library Center (OCLC), and a national library network. The Barry University Dwayne O. Andreas School of Law houses an extensive collection of legal materials including Federal and State Statutes, case reporters and digests, monographs, treatises, secondary resources, legal periodicals, and newspapers, with a focus on Florida specific legal resources. Reference librarians with law degrees are available to assist with research and reference for students, faculty, and members of the Orlando legal community.

Under ASC 740, the University must recognize the tax benefit associated with tax positions taken for tax return purposes when it is more-likely-than-not that the position will be sustained. Management of the University does not believe there are any material uncertain tax positions and accordingly has not recognized any liability for unrecognized tax benefits. The University has filed for and received income tax exemptions in the jurisdictions where it is required to do so. Additionally, the University has filed Internal Revenue Service Form 990 tax returns as required and all other applicable returns in those jurisdictions where it is required. The University believes that it is no longer subject to U.S. federal, state and local, or non-U.S. income tax examinations by tax authorities for years before 2010. However, the University is still open to examinations by taxing authorities from fiscal year 2010 forward. For year ended June 30, 2015 and 2014, there was no interest or penalties recorded or included in the consolidated statements of activities. Earnings from unrelated business activities were not significant for the years ended June 30, 2015 and 2014. Accordingly, no provision for income taxes has been made in accompanying consolidated financial statements.
