28) In November, we participated in Farm City Week held at Heritage Village in Largo. Our volunteers in conjunction with FNGLA, UF/IFAS, FFA, and the Pinellas County Government were able to serve over 500 people. This years theme was small farm animals. There were multiple commodity stations set up for hands on experiences. These stations included ice cream making, butter, squeezing orange juice, tie dyeing with vegetable dyes, and weaving. There were also games and small animals. Animals included rabbits, chickens, pigs, alpacas, a mini horse and goats. This event gives us the opportunity to educate the urban population about the importance of agriculture.

29) During the Great American Teach In, our volunteers visited local elementary schools and read an agriculture related book to pre-K children. The children learned how cream becomes butter thru a hands on demonstration.

30) Each year we co-sponsor the annual State Floriculture and Nursery/Landscape career development day. The event is attended by students, advisors, and volunteers. At school, students are taught the fundamentals and then are given the opportunity to demonstrate what they have learned through projects and testing. The purpose of this event is to help students gain practical knowledge about the industry.
