The Children's Shelter Home, founded in 1985, is a residential ministry serving children who have been removed from parental custody by the state of Florida because of abuse or neglect. The children, who stay for an average of 9 months, are cared for 24 hours per day and take part in all age-appropriate activities offered through the First Baptist Church of Leesburg, Inc. 66 foster children were admitted to the Children's Shelter Home during the year.

The Samaritan Inn (Homeless Family Shelter), opened in 2010. It serves homeless families who are not presently dealing with addiction or facing felony charges. The Samaritan Inn is currently Lake County's only shelter for intact homeless families. During the year a total of 73 men, women, and children transitioned from homelessness to economic self-sufficiency.

The Men's Residence, founded in 1982, is a residential ministry to men struggling with drug and alcohol issues. The Men's Residence has a seven and a half-month program which offers counseling, life skills, access to employment re-training, and various other services as needed. The Men's Residence has an average 12-month post-exit sobriety rate of roughly 40 percent, approximately twice that of the national average. A total of 72 men were assisted via the Men's Residence and a total of 10,235 meals were served to the homeless and needy during the year.
