The ReadingPals Initiative focuses on early literacy intervention and reading readiness Caring adults are matched one-to-one with a student who has been identified as a struggling reader Using a developed curriculum, each ReadingPal commits one hour a week for the entire school year to read to the same child and work on literacy skills Each student takes home a brand new book every week For the 2014-15 school year, 250 ReadingPals volunteers were trained and deployed in 13 schools in Leon & Gadsden Counties and read to 238 students Of the 238 students, 112 students were both pre-and post- tested In the areas of both letter naming fluency and reading curriculum-based measurement, the ReadingPals students outperformed the overall district in growth percentages Specifically, for the Reading curriculum-based measurement test, the ReadingPals students increased their scores on average of three times the rate of their peers who did not receive the additional intervention Approximately 5,400 books were distributed as part of the ReadingPals Initiative Students participating in the ReadingPals program increased reading scores on average at three times the rate of their peers that did not receive assistance

The Volunteer Income Tax Assistance (VITA) effort (part of our financial stability effort titled Believe, Earn, Save, Thrive - B E S T) offers free tax preparation by IRS-certified volunteers This fast and free service helps Big Bend residents avoid predatory income tax preparers and costly refund anticipation loans In the 2015 tax season, VITA prepared free tax returns for 3,913 residents saving them more than \$821,730 in tax preparation fees, enabling families to claim \$1,052,600 in Earned Income Tax Credits, and bringing more than \$4,700,300 million in tax refunds back into the community
