THE ORGANIZATION MADE A GRANT OF \$21,350 TO THE KENTUCKY OFFICE FOR THE BLIND THAT ENABLED THAT GOVERNMENTAL AGENCY TO OBTAIN ADDITIONAL MATCHING FUNDS FROM THE U.S. DEPARTMENT OF EDUCATION OF APPROXIMATELY \$78,000. THE KENTUCKY OFFICE FOR THE BLIND PROVIDES REHABILITATION SERVICES TO INDIVIDUALS WHO ARE BLIND AND VISUALLY IMPAIRED TO HELP THEM DEVELOP SKILLS TO LIVE AND WORK INDEPENDENTLY IN THEIR COMMUNITIES. THIS TOTAL OF JUST OVER \$100,000 ALLOWED 73 MORE INDIVIDUALS NEEDING VOCATIONAL REHABILITATION TO RECEIVE SUCH SERVICES.
